संदर्भ :- आपला दि.२०.०२.२०२४ रोजीचा प्रस्ताव.

उपरोक्त संदर्भिय पत्रान्वये आपल्या दि मॉडर्न स्कूल (इंग्रजी माध्यम) व्ही.पी.रोड, सिक्का नगर, मुंबई या इंग्रजी माध्यमाच्या सीबीएसई अभ्यासक्रमाच्या प्राथमिक ते माध्यमिक (इ. १ ली ते १० वी) शाळेतील विद्यार्थ्यांना गुणवत्तापुर्ण शिक्षण देण्याच्या हेतुने शाळा दोन सत्रांमध्ये चालविण्यासाठी आपणांकडून या कार्यालयाकडे विनंती करण्यात आली आहे.

प्रस्तृत प्रकरणी माध्यमिक शाळा संहिता नियम क्र.५५.१ नुसार शाळेच्या जागेची अडचण दूर करण्यासाठी समुचित प्राधिकाऱ्यांनी शाळांची निकड म्हणून त्यांना दोन पाळ्यांत काम करण्याची परवानगी देण्याची तरतूद आहे. मात्र, अशा शाळेत प्रवेश घेवू इच्छिणाऱ्या या सर्व विद्यार्थ्यांना प्रवेश देऊ शकणारी व अशा पध्दतीने काम करणारी त्याच प्रकारची इतर कोणतीही शाळा त्या वस्तीत नसली पाहीजे. तसेच माध्यमिक शाळा संहिता नियम क्र.५५.३ (अ), (ब), (क) व (ड) प्रमाणे वस्तुस्थिती असल्यास सदर शाळेस त्यांनी केलेल्या विनंतीच्या अनुषंगाने

शाळा दोन पाळ्यांमध्ये भरविता येईल, अशी तरतूद आहे.

त्या अनुषंगाने सदर शाळा दोन सत्र/पाळयामध्ये सुरु करण्यासाठी शाळेने उक्त नमृद अटींखेरीज बोलकांचा मोफत व सक्तीच्या शिक्षणाचा अधिकार अधिनियम, २००९ व महाराष्ट्र बालकांचा मोफत व सक्तीच्या श्राक्षणाचा अधिकार अधिनियम, २०११ मधील सर्व तरतूर्दीचे पालन करण्याच्या अटी/शर्तींच्या अधीन राहून पुढील योग्य ती कार्यवाही करावी. सदर बाबत कोणत्याही शिक्षक, विद्यार्थी वा पालक यांच्या तक्रारी या कार्यालयास प्राप्त होणार नाहीत, याची दक्षता घ्यावी. उक्तप्रमाणे नमूद केलेल्या कोणत्याही नियमाचे शाळेने उल्लंघन केल्यास सदर

आदेश तात्काळ प्रभावाने रह समजण्यात येतील यांची नोंद घ्यावी.



: Regarding permission to run school in double session -

The Modern School Sikka Nagar, Mumbai.

Reference: Your proposal dated 20.02.2024.

According to the above reference letter, Your the Modern School (English Medium) V.P.Road, Sicka Nagar, Mumbai you have requested this office to run the school in two sessions for imparting quality education to the students of English Medium CBSE syllabus from Primary to Secondary (Std. 1st to 10th).



In the present case, according to Rule No. 55.1 of the Secondary School Code, there is a provision for the appropriate authorities to allow the schools to work in two shifts as an emergency to remove the problem of school space. However, there should not be any other school of the same type in the locality which can admit all these students who want to get admission in such a school and operate in such a manner, Also, there is a provision that according to the request made by the said school, the school can be held in two shifts if there is a fact as per rule no.55.3 (a), (b), (c) and (d) of the Secondary School Code

Accordingly, in order to start the said school in two sessions/daycares, the school should take further appropriate action subject to the conditions of compliance with all the provisions of the Right of Children to Free and Compulsory Education Act, 2009 and the Maharashtra Right to Free and Compulsory Education Act, 2011 apart from the above mentioned conditions. Care should be taken that this office does not receive any complaints from teachers, students or parents regarding the same. Please note that if the school violates any of the rules mentioned above, the said order will be deemed cancelled with immediate effect.
